# **OVERVIEW** FOR FY2023

All information contained within this annual report is based on the 12-month period ending June 30, 2023. The Financial Literacy Commission has begun producing its annual report on a fiscal year basis to align with the Commission's budget year and the academic year typically observed by Tennessee school districts. The previous annual report was produced as of December 2022. The next annual report will cover July 1, 2023 through June 30, 2024.

# HIGHLIGHTING THE SUCCESS OF ESTABLISHED PROGRAMS

### \$martPath

The TNFLC first piloted a new digital learning platform in Tennessee Schools during the 2021-2022 school year with great success. \$martPath has since become the flagship digital platform offered by the Commission to Tennessee classrooms. \$martPath is an award-winning curriculum that offers an engaging, interactive and easy way for elementary and middle school teachers to integrate relevant and fun economic and financial education in their classrooms. \$martPath units teach students about personal financial responsibility such as saving, prudent spending, and prioritizing needs and wants through grade-appropriate, curriculum-aligned, interactive lessons.





**822** educators guided an estimated **43,650** students through \$martPath during the 2022-2023 school year



**169,859** total students have used the Commission's digital financial literacy offerings since 2015

Teachers reported a 33% gain in their confidence in teaching financial literacy after introducing the program to students

#### Pre-test/post-test results show:



**19%** gains in student financial knowledge



**77%** increase in grasp of needs and wants, budgeting, payment methods and more





### My Classroom Economy

The My Classroom Economy program is a innovative classroom behavioral management program designed to instill basic financial responsibility and the value of delayed gratification. Classroom educators have enjoyed the inherent behavioral and motivational impact of the program, while students gained real-life financial understanding and capability acquired through this experiential-learning based program.



### **My Classroom Economy Masterclass Series**

The Commission provided a deep-dive professional development series for teachers ready to implement the My Classroom Economy program. Over multiple sessions, the Masterclass addressed best practices, challenges, and worked together to make the program successful for any classroom!

In the post-Masterclass survey, 42 teachers indicated they had already implemented My Classroom Economy this year, and 98% reported that attending the Masterclass series increased their likelihood of implementing the program with their students. Additionally, 83% of respondents teach in a Title 1 school.





### Financial Literacy Grants for Libraries

The Tennessee Financial Literacy Commission designated special grants designed to bolster financial literacy outreach and resources for children and families in their local communities. The first round of grants was awarded in July 2022 to libraries in Clay, Cocke, Grundy, Lake, Lauderdale, and Perry counties, six of Tennessee's most economically distressed counties. The libraries are using funds to create and stock dedicated areas around financial topics for their communities to facilitate multigenerational learning.



# **Enrich Financial Wellness Platform**

Enrich is a high-quality digital learning platform designed to strengthen financial wellness using personalized tools to help teens and adults at any stage in their financial journey. In partnership with the National Association of State Treasurers, the Commission launched the Enrich platform for Tennesseans in the fall of 2022. In FY23, 176 adults created accounts and used the platform to access financial literacy tools, view webinars and create action steps toward meeting their financial goals.

# **Money Week with UT Extension**

In 2022, the Commission partnered with UT Extension to sponsor Money Week in 12 elementary schools. Based on the success and popularity of the first year, we were thrilled to expand the program in 2023. Our sponsorship funded teaching supplies, books, and other program materials for 20 Tennessee schools during the 2022-2023 school year.

Money Week is a week-long financial literacy celebration for first- and second-grade classrooms and includes story time with special guest readers. Parents receive a daily (bilingual) newsletter on the day's lesson with accompanying activities for families to do at home. At the end of the week, each student is gifted a children's literature book about money.







In 2023, 2,019 1st and 2nd grade students from 20 schools throughout TN participated in a full week of learning money management basics. Teachers reported:

The Tennessee Financial Literacy Commission connects Tennessee's K-8 educators with our full range of financial literacy resources and delivers training on each program through a series of virtual financial literacy training sessions designed for K-8 educators. Through these 60-minute webinars, Tennessee educators gain the tools and knowledge to prepare their students for navigating life's financial milestones.

**70%**, or **473** teachers, attended three or more sessions per series

# **Traveling Trunk: From Barter to Budget**

In partnership with the Tennessee State Museum, we are proud to offer "From Barter to Budget," a Financial Literacy Traveling Trunk which is designed to introduce hands on financial literacy learning activities combined with Tennessee history. Teachers can request the trunks to be delivered to their classrooms across the State, and the interactive lessons inside align with Tennessee Academic Standards for Social Studies.



Trunks were reserved by educators in **17** schools reaching a total of **2,225** students during the 2022-2023 school year
